Proposed Amendments to The Town of the City of Dawson Council Proceedings ByLAW #11-12

That Section 5: MAYOR, be amended to read:

### 5. CHAIRPERSON

Per Section 180a of the Municipal Act, the Chairperson shall preside over the conduct of the meeting and:
1) shall maintain order and preserve the decorum of the meeting;
2) shall decide points of order without debate or comment other than to state the rule governing;
3) shall determine which member has the right to speak;
4) shall rule when a motion is out of order;
5) may call a member to order;
6) shall be permitted to participate in the debate of any matter without the need to relinquish the Chair; and
7) shall vote on every matter unless they are excused or disqualified from voting pursuant to the provisions of the Municipal Act.

And That Sections 9.5 and 9.6 revised to read:

5) Chairperson to Open Meetings. When a quorum is present, the Chairperson must call the meeting to order and shall serve as Chairperson of that meeting.

6) Appointment of Chairperson.

1. At the first meeting of each calendar year Council shall, from amongst its Members, designate a Member to serve as Chairperson

2. When a quorum is present, but the Chairperson is not present within fifteen (15) minutes after the time at which the meeting is scheduled to begin, the Chief Administrative Officer shall call the meeting to order and, by resolution, the Council shall appoint a Member to act as Chairperson for that meeting.

And that a new section be added to read:

### REVIEW

During the first six months of council's term of Office, council shall schedule a review of the Council Proceedings Bylaw and proceed to amend it if deemed advisable at that time.

### Recommendation

That Council direct Administration to enter into a lease agreement with Tr'ondëk Hwëch'in (TH) for the provision of their Nutrition Program at the Art & Margaret Fry Recreation Centre for a monthly lease rate equal to or greater than the rate charged in the previous year arrived at through competitive tendering , plus propane cost for a term commencing September 1, 2023, and expiring August 31, 2024.

### **Executive Summary**

Tr'ondëk Hwëch'in operates a school food program that is available to all students. TH does not have adequate facilities to provide the full program and have requested the lease of the kitchen facilities at the Recreation Centre. Given the community benefits of the program to the entire community staff recommend leasing the kitchen facilities for the school nutrition program. Doing so will mean there will not be a commercial kitchen on a regular basis at the arena and staff believe this can be partially compensated for via vending machines and potentially canteen service availability for tournaments.

### Background

Tr'ondëk Hwëch'in approached the City of Dawson with a request to lease the kitchen to provide their Nutrition Program, which is operated by their Education Department. The main intent of this request is to provide food for all Robert Service School students five days of the week. Tr'ondëk Hwëch'in's request is to utilize the kitchen as a site to prepare meals, as well as to operate it as the cafeteria for high school students during lunch hours. For more details on the Nutrition Program, see the attached document – TH Nutrition Program.

Their request comes due to a lack of industrial kitchen space at the school and too many programs operating out of the kitchen at the TH Hall. These factors have limited in what they can provide.

The Art & Margaret Fry Recreation Centre is typically leased, based on a Request for Quotations, by a business-owner between October and March, to sell food to users of our facility and the public. The last number of years this tender has had limited interest.

Discussion / Analysis		

Property Lease Policy 2017-5

The Property Lease Policy regulates the leasing of City of Dawson property and facilities for public use for periods more than 14 days. Any agreement beyond this period must be approved by Council. For this reason, we are bringing this item forth to Council. Administration believes the prospective lessee adheres to the objectives of this policy, mainly based on the benefit it offers our community.

The process of this policy generally involves making the space equitably available to the public, which is our standard practice for this space. However, based on the nature of this request; our ongoing efforts to partner with Tr'ondëk Hwëch'in; and the adherence to the attributes and objectives of our Property Lease Policy, Administration recommends that Council direct Administration to forego our standard process, based on section 4.3 of this policy, which allows Council by resolution to direct Administration to modify the application and approval process.

### Challenges/Risks

There are challenges with the lease that has been requested. However, Administration believes these are surmountable:

• Lack of Public Concession for Users

It is a concern that we would not have a public concession to feed users throughout the skating season. However, this program offers an immense benefit to the health of our youth and the community. To ensure users have some eating options at this facility, Administration plans to install vending machine(s). Administration believes we have time to stock these machines, and they will likely offer a new source of revenue.

• Lack of Places to Eat in Winter

Although there remain portions of the winter where we lack many eateries in our community, the number of restaurants open in the winter has vastly increased compared to when the Recreation Centre was initially built.

• Increased Traffic / Unsupervised Youth

We expect this request to result in additional youth in our space, increased usage of our washrooms and increased traffic in the concession space as a whole, mainly while it operates as a cafeteria. We have reassurances that the high school students would be supervised, and we see the increased visitation of youth as an opportunity to get more of them utilizing our facility and programs.

• New Model / Unknowns

As this would be a new model, and a new type of operation within our facility, there are reservations and risks which this lease could present which we will not be made aware of until it comes into effect. For these reasons, we only recommend agreeing to this request for one year at this time. Based on conversations and our ongoing positive relationship with Tr'ondëk Hwëch'in, and Robert Service School, we believe that all challenges are surmountable within a year timeframe.

#### **Fiscal Impact**

### Lease Amount

If approved, the final lease rate and elements will be discussed in Camera but the lease rate will be at or above the previous years lease rate which was arrived at through a competitive bidding process. A competitive bidding process is the surest way to establish a fair market price.

Proceeding in this manner will ensure a minor positive impact on the Municipal Budget

### **Alternatives Considered**

Continue with current process of public tendering for the use of the Concession space.

- Negative Limited business at the site has driven down the lease bid results and proven to be a challenging business environment over the years. The TH nutritional program requires additional space to fully meet demand for the program and the Rec facilities have been identified as best fit so program may not be able to maximize benefits.
- Positive it is assumed that food and snacks would remain in place for arena users .
- 2<sup>nd</sup> or third best choices for TH program can be suggested to TH such as the Curling Club or commercial Kitchens although these may or may not be suitable
- Tendering process would take time and TH program needs to get up and running ASAP If TH participated in a tendering process there is no guarantee that they would the successful bidder and they would then have to review alternative options for the nutrition program

Next Steps

Upon approval Staff will sign a Lease Agreement with Tr'ondëk Hwëch'in.

### Recommendation

That Council authorize the purchase of Shred-Tech Model ST-15E Stationary Shredder to be installed at the Diversion Centre for \$62,354 plus shipping, as required under the provisions of section 3.1.1 of the Procurement Policy (purchases in excess of \$50,000).

### **Executive Summary**

As part of the operations at the Diversion Centre, a commercial shredder would add great value to the City as well as provide value in the community. This commercial shredding machine requires the authorization of council as the purchase price exceeds \$50,000. No budget amendment is required as it was captured in the Diversion Centre equipment costs budgeted for 2023.

#### Background

As part of our Records Management strategy, it is necessary that certain documents will be destroyed when authorized. Due to possible sensitivity of such information, commercial shredding of the documents is best practise. Storage of the City's archived documents have met capacity in our storage unit and the excess is being temporarily stored in the City Main offices, putting stress on the building structure. The City approached the only commercial shredding service located in Whitehorse and learned that the company was ceasing operations and could no longer provide the service. We began researching other options, but the final result was that the City acquire its own shredder. Due to the fact that over 100 boxes of archived materials will meet the requirement for disposal over the next few years, the recommended course was to purchase a commercial shredder.

### **Discussion / Analysis**

Staff researched availability of commercial shredding machines that could meet the following requirements:

- 1) Could handle an entire filing box of documents at a time
- 2) Had a conveyor type lift system, as many of the archived boxes weigh a considerable amount (safety consideration)
- 3) Did not require the removal of paperclips, staples or other binding materials
- 4) Could handle heavier grade materials such as cardboard covers
- 5) Met the space requirements available in the Diversion Centre
- 6) Available in Canada

Management followed the principles as outlined in section 1.2 and determined that due to the limited number of companies providing this equipment in North America, a single source approach was necessary. And based on the requirements listed above, only one company was found in Canada that distributes a commercial shredder that meets the above criteria – Shred-Tech Corporation.

### **Fiscal Impact**

There is no impact to the budget as it was estimated in the equipment acquisitions of the Diversion Centre and originally budgeted for \$70,000. Since the only commercial operation in the Yukon has ceased operations, the City can provide this service to business, governments and residents of Dawson and the surrounding area for a fee, adding much needed revenue to the Diversion Centre operations.

Funding is primarily from Gas Tax funds.

### **Alternatives Considered**

**Shipping the boxes to a commercial shredding service outside of the Yukon** – The sensitivity of some of the documents, especially those containing account number and names, would require a staff member to accompany the boxes for safe storage. The labour, travel and freight costs would not make this option cost effective in the long run.

**Purchasing a smaller office shredder** – this was deemed as too labour intensive as large metal clips and certain thick binding materials would have to be removed. The sorting and shredding of each box would be cost and time prohibitive when considering the number of boxes currently on the premises and in storage.

#### **Next Steps**

Administration respectfully requests from Council approval to purchase the Shred-Tech Model ST-15E Stationary Shredder.

### **Executive Summary**

Mayor Kendrick, Councillor Somerville, and CAO Henderson attended the federation of Canadian Municipalities (FCM) 2023 conference in Toronto from May 25 to May 28.

The conference had a full slate of Daily Main floor presentations as well as smaller subgroup presentations, workshops, and regional caucus meetings on Municipal topics and issues common to Canadian municipalities.

During the trade show the exhibitors hall was open where hundreds of government agencies, programs, and suppliers displayed their wares and programs and answered questions.

Attendance is considered valuable for informed decision making by elected officials and senior staff. Attendance is also valuable for developing contacts for government programs and Municipal specific suppliers

### Background

The Federation of Canadian Municipalities (FCM) has been the National Municipal Organization since 1901 with 2,100 municipalities as members representing approx. 90% of the Canadian population.

The organization advocates for municipalities with the Federal Government for federal programs and policies.

FCM has two primary meetings per year -

- The annual Conference and trade show which is held in a different municipality each year and is attended by 1500 2,000 delegates from across the country – Members of elected councils from both small and large municipalities plus CAO's or senior administrative staff. Attendees listen to presentations on Federal programs and issues, attend workshops on various issues, connect with municipal representatives from similar communities and discuss common issues and solutions. The conference has a large trade show where agencies and suppliers present and discuss their programs and services.
- 2. **The annual lobbying attendance in Ottawa** as part of the advocacy on behalf of Municipalities usually attended by elected officials or staff directly involved in lobbying specific issues with the federal government.

FCM also provides ongoing training programs and Funding programs primarily around green initiatives.

The Councillor Convention Attendance Policy authorizes each member of council to attend the FCM conference once during their term of council or additionally if specifically approved by council.

The City of Dawson Travel Policy identifies the process for approval to attend conferences , expense claims, and reporting out

### **Discussion / Analysis**

Attendees utilized a number of study tours scheduled by the host municipality on Heritage Planning, Equity Planning, Waste to renewable gas, Smart Cities, residential density etc....

Speeches on national issues were received from National party Leaders and representatives, a New Framework for Municipalities was discussed , a discussion of Municipal issues in the next federal election.

Lunch and learn sessions on various topics provided.

A Northern Territories Caucus meeting was held with FCM representatives to discuss issues specific to the North.

Workshops included HR Recruitment and staff retention in a competitive environment, advocating for rural communities, Climate solutions, Canada's next generation of Housing, Think Globally act Locally, P3's and the public Interest, action against online harassment,

FCM 2023 also including a business agenda whereby the Board members and regional representatives were elected.

Trade show Booths were arguably the most productive aspect for the CAO with multiple potentially useful contacts on the following areas -

- Engineering companies serving the Northern territories and dealing with various projects including wastewater treatment, recreation facility construction, heating systems, and roadwork
- Various digital online services that allow municipal transactions and payment online
- Canoe procurement group which is a public sector buying group that uses common tender documents and group buying to lower municipal costs (AYC is looking at utilizing this group for AYC members)
- CIMCO refrigeration specialists in Arena refrigeration a current supplier of Dawson with a discussion of new systems they use for new builds
- Various companies that provide emergency digital communications services via text messaging / email / etc for emergency notifications
- CMHC discussion of housing programs
- Waste Container manufacturers
- Fire Marque a company that bills insurance companies for municipal costs related to a fire or accident.
- Redbrick Communications discussions

### **Fiscal Impact**

The approx. cost for an individual to attend the FCM conference in Toronto, all taxes included is \$5, 675. This cost includes flights from Dawson to Whitehorse to Toronto and return Flights, Hotels in Whitehorse and Toronto, conference registration of \$1,163 each. Plus applicable taxes.

The 2024 conference is in Calgary Alberta and travel and accommodation costs should be lower.

The value of this investment is in the education of participants, knowledge of legislation and funding programs, connections with the people developing and awarding funding, lobbying upper government on funding and program issues specific to the remote North, connecting with Fellow Yucon Municipal leaders and staff on the same issues and developing solutions.

The general structure of Municipal governments and services is common across the country and the issues and challenges faced by Yukon Municipalities tend to be unique variations on common issues, so the solutions developed in other communities often have transferability to issues encountered in Dawson.

### **Alternatives Considered**

Dawson policies cover elected official attendance at the Association of Yukon Communities annual conference – to be held in Dawson in 2024 and 2025. This conference compliments the FCM conference and focuses more specifically on Yukon issues

Senior administrative staff attend role specific conferences as well as the FCM and AYC conferences depending on availability.

### **Travel Report**

Mayor Kendrick, CAO Henderson, and Councillor Somerville attended the 2023 Federation of Canadian Municipalities (FCM) Annual Conference in late May/early June. CAO David Henderson has also provided a travel report that provides, amongst other things, some background information about FCM and some general information about the conference. This brief report covers a summary of some other items that Dawson Council and the community may find of interest.

Mayor Kendrick and Councillor Somerville participated in the annual meeting and voted on a variety of resolutions put forward to advance municipal priorities. A key resolution made was an appeal to the federal government to work on a new Municipal Funding Formula/New Fiscal Framework that will better finance municipalities to deal with rising costs, pressures for new services, adapting to climate change, and the needs for new housing to address rising populations.

Mayor also attended a variety of sessions including one on working to fight online harassment, and how to work together to shape a more positive and welcoming landscape for municipal politics and new participants to local democratic institutions.

Dawson City attendees participated in the Northern Territories Caucus meeting. There was also a Northern Reception, which was new to FCM, as previously the North has been lumped into a reception with northern portions of many provinces.

Below, a few highlights illustrate some of the value and insights that can be gained from participating at a FCM Annual Conference.

### Finding the Missing Middle: Low-Rise Housing Study Tour

Mayor participated in this study tour, which was given by a City of Toronto planner. Its focus was on how laneway suites and garden suites are helping to address the housing shortage, and how they can be encouraged. Flexibility is critical. Key elements of their strategy included the following:

- Development charges are waived and there are also financial incentives if the housing is affordable (up to \$100K per unit this is Toronto!)
- Laneway and garden suites are connected with water and sewer from the existing dwelling on the property, thereby minimizing the ripping up of existing infrastructure, and reducing expensive piping and installation costs. Water is charged by metering in Toronto.



Laneway and Garden Suite Study Tour

- No parking minimums although residential parking zones apply.
- No minimum size requirements for dwellings, and lot consolidations in certain zones are not allowed.
- When consulting the population about their strategy, they did so with virtual engagement sessions.

### Conversation with the Mayor of Fernie, B.C.

While on the shuttle bus back from the closing dinner, Mayor had a conversation with Fernie, B.C.'s Mayor Nic Milligan. The Town of Fernie, with a population of approximately 5,000, is a tourism and mining community and has many similar challenges to Dawson.

- Fernie has an accommodation levy (aka Hotel Tax) which is applied to hotels as well as Air BNBs and VRBOs that generates revenue for the municipality.
- Rather than try to monitor these AirBNBs and VRBOs themselves, the municipality utilizes a third-party called AirDNA to monitor and calculate levies and fees on these short-term rentals in the community.

### **Trade Show**

There were literally a hundred or so non-profit organizations and businesses participating in the trade show. I will highlight two exhibitors of interest below:

### **Food Cycle Science Corporation**

This company has received funding through Agriculture Canada to increase food waste diversion from landfills. They are looking to partner with small, rural, northern, and indigenous communities to offer innovative residential food waste diversion solutions, and are currently partnered with 94 municipalities, including Nelson, B.C. and Bancroft, Ontario. The company is actively seeking additional partners, and has contacted Dawson City to see if the town is interested. More information can be found here:






Figure 1. Map amendment




Figure 1. Map amendment.

#### **Executive Summary**

The applicant has submitted an application for an OCP/ZBL amendment to amend the designations for their claims from various zonings to Industrial, to facilitate an existing Class 4 placer mining operation.

#### Background

These bylaws received their first reading on May 17, 2023. The text in draft bylaws has been modified to exclude the parts of a claim that overlap residential areas.

2<sup>nd</sup> Reading has been delayed pending additional review of concerns identified by Tr'ondek Hwech'in, and additional review of zoning history and legal questions. These questions appear to be satisfied sufficiently at the current time to move to 2<sup>nd</sup> reading.

#### **Discussion / Analysis**

It should be noted that there are First Nation Settlement Lands within 500 meters of the amended area, necessitating the sending of notification letters to TH prior to the public hearing. Staff initially overlooked this. Since then, TH Land Planning has been contacted to initiate consultation. The above-mentioned text amendment has been done per TH's recommendation.

Staff also contacted the YG Mining Administration Officer to query about the reclamation plan approval procedure. During the meeting, it was determined that a copy of the plan will be sent to the City and TH for their input on the plan prior to its approval. CoD Staff were informed that the proponent is still finalizing the plan. This will be addressed once the Development Permit for Mining is submitted.

The City is presently working with lawyers to draft an effective relinquishment agreement that addresses all parties involved.

#### **Alternatives Considered**

Do not give Second Reading to Official Community Plan (OCP) Amendment No. 11 (Bylaw #2023-10) and Zoning Bylaw Amendment No. 22 (Bylaw #2023-11). Considering a 45-day ministerial approval period, this would however hinder the process.

#### **Next Steps**

Before the Third Reading, the OCP amendment will be sent to the Minister for their approval.

### Recommendation

That Council give First Reading to Zoning Bylaw Amendment No.24 (Bylaw #2023-13).

#### **Executive Summary**

The proposed amendment will define and add "Microbrewery/Craft Distillery" as a Permitted Use for commercially zoned properties (C1).

#### Background

The applicant contacted the Planning staff to inquire about the necessary steps for operating a small brewery as a "home industry" on their property. They were informed that home industries are not permitted in the R1 (Single Detached and Duplex Residential) zone. It was also noted that the addition of home industries to R1 is undesirable from a planning standpoint due to the risks associated with these types of uses, such as safety, fire, odour, etc.

Due to their size and primary focus on product manufacturing and distribution, distilleries and breweries were traditionally viewed as exclusively industrial activities. In Canada, the microbrewing and craft distilling industries have experienced significant growth in recent years. As such, the Planning Department received a request for a Zoning Bylaw amendment to facilitate the possible operation of a craft distillery in the city.

Distilleries are currently only allowed in the M1 Zone (Industrial), regardless of the volume of production. There is no industrially zoned space in the historic townsite that causes even the smallest companies to look for a location outside of the historic townsite where they are outside of the reach of the city's services. This is disheartening in light of the possibility of local small-scale distilleries developing into restaurants or bars that enrich the city's culture.

Due to this application and the growing interest in these industries, the staff recommends amending the Zoning Bylaw to include Microbrewery/Craft Distillery as a permitted use in C1 Zone (Core Commercial) where they are appropriate.

#### **Discussion / Analysis**

Small-scale beer and spirit production would be allowed in addition to retail sales, a tasting room, and/or a restaurant, all of which might be provided in a single location, if Microbrewery/Craft Distillery was added as a permitted use in the C1 Zone.

#### **Municipal Act**

Section 289(1) states that "[a] zoning bylaw may prohibit, regulate, and control the use and development of land and buildings in a municipality." Moreover, section 290(1)(c) includes "the class of use of land or buildings or both that shall be subjected to special regulations or standards" as a content of zoning bylaw.

#### **Official Community Plan (OCP)**

This is how the OCP describes Downtown Core:

"This location is recognized as the heart of Dawson City since it accommodates a broad range of uses focusing on the commercial, cultural, and community needs of residents and visitors."

The proposed bylaw amendment corresponds to this description. In addition, it promotes the city's economic growth as specified in section 8.0: "Economic development involves supporting new or existing economic sectors, attracting new businesses, and creating an environment where different economic interests are balanced."

#### **Zoning Bylaw**

The purpose of the C1 zone is to permit a mixture of commercial and residential uses and to promote a vibrant commercial core.

The proposed amendment only includes Microbrewery/Craft Distillery as a Permitted Use for commercially zoned properties. However, distilleries and breweries may remain in the M1 zone if they do not operate a lounge. This assures that manufacturing-focused breweries and distilleries can only be located on M1-zoned properties, whereas retail and commercial ones may be on commercially zoned properties.

### **Department Heads**

This application was circulated to all department heads, and no comments or concerns were received at the time of writing this report.

### **Building Code**

When a structure is designed as a distillery, they fall under the Part 3 Classification as per the code and further would require the involvement of a full design team consisting of professional architects and engineers to ensure all life and safety requirements have or will be achieved.

#### **Yukon Liquor Corporation**

The following three inquiries were directed to Yukon Liquor Corporation. Their response is highlighted in red below.

- Is there a distinction in your legislation between "craft distillery" and "industrial distillery"? There is no distinction in our legislation between craft or industrial.
- Is there a maximum annual output volume for craft distilleries? The maximum output from a craft to industrial distilleries would be markup on liquor tax.
- Is there a floor area minimum and maximum for craft distilleries? No minimum floor area.

Unlike British Columbia regulations, the Yukon Liquor Corporation does not distinguish between craft and industrial distilleries. Therefore, a precise definition of the term is required in the Zoning Bylaw to ensure that industrial distilleries are not permitted in the downtown core.

#### Definition

The following definition is suggested to be added to the section 2.2 of the Zoning Bylaw:

**Microbrewery/Craft Distillery** means the distilling or brewing of alcoholic beverages or alcoholic products with a maximum annual production of 50,000 liters. Product tasting and retail sales of all products produced on-site is permitted. All equipment and manufacturing processes must be contained indoors up to maximum floor area of 275m<sup>2</sup>, and shall not create a nuisance. Limited outside storage of product for display and distilling purposes is permitted provided the storage area does not encroach into public land, parking areas, drive aisles or access to a building.

This definition is consistent with definitions and regulations in municipalities in British Columbia that have proven effective. Maximum annual production volume and floor area will guarantee that the operation is not industrial.

Do not pass First Reading of Zoning Bylaw Amendment No.24 (Bylaw #2023-13).




Figure 1: Existing and proposed lot configuration.

#### **Discussion / Analysis**

#### **Municipal Act**

As per the Municipal Act S. 322(3), "the period of time for which the plan of subdivision approval is effective and within which the plan of subdivision must be submitted to the land titles office must not exceed 12 months from the date of approval of the application unless the applicant and the approving authority agree to a further 12 month period".

The Municipal Act S. 319(2) states "Approval of an application shall be valid for a period of 12 months and may be subject to renewal for one more period of 12 months at the discretion of the approving authority".

#### **Alternatives Considered**

Council does not grant extension authority to consolidate Lots 15 (N¼), 16 and 17 (S½), Block J, Ladue Estate (Consolidation Application #22-075).
